FACING A FUTURE WITH ASSISTED SUICIDE

A Citizens With Disabilities – Ontario Webinar

While the public continues to debate whether assisted suicide should ever be allowed, the real questions we now need to answer have changed.

As a result of the Supreme Court of Canada decision in the *Carter* Case, we now know assisted suicide will be legal for what is agreed will be a very small group of people, but remain a criminal act for everyone else.

- **Criteria:** How will that small group of people be clearly and consistently identifiable?
- **Prevention:** How will the vulnerable be protected and alternatives, such as effective palliative care, be made available?
- Physicians: Apart from assisting death to ultimately occur, what is the appropriate and necessary role for physicians in the process?
- Safeguards: Should the review process take place before or after death?
- **Federal Role:** Since assisted suicide will remain subject to criminal sanction, is a federal law required?
- **Provincial Role:** What obligations do the provinces have to provide alternative treatments and services, to fund physician assistance, and establish the review process?

These questions will be addressed by CWDO's expert panel of disability rights lawyer **David Baker**, and health law expert **Gilbert Sharpe** in a webinar to be held October 4, 2015 at 2:00 pm Eastern Daylight Time.
